Voting Process:

Each member (real property owners of record and year-round renters in the Potomac-Westmoreland Shores subdivisions) shall be entitled to cast, as many votes at the election of directors as there are Directors to be elected, but cumulative voting shall not be allowed. Candidates for office receiving a simple majority (51%) of all votes cast shall be declared elected. Their term of office shall begin at the close of the annual meeting at which they are elected.

2. Absentee Vote

Absentee ballots will not be counted by a board member. We will request two non-board members to count absentee ballots.

Rules for Absentee Voting

- Must be a current PWSCC member by May 31, 2024, 5:00 p.m.
- Each member, as defined above, can have up to two ballots. For example, one for husband and one for wife.
- Ballots must be placed in an envelope, sealed, and your name written on the envelope.
- If residents place multiple ballots in an envelope, all names must be written on the envelope.
- Place sealed envelopes in the dropbox at the clubhouse near the library.
