Boat Slip Rental & Ramp Key Purchase

Boat slip rentals and ramp keys are valid for one Season. The season begins on April 1st of the current year and terminates May 31st of the following year.

Keys will be available within 10 days of receiving an application.

Proof of insurance is required each season and must be submitted with this completed form. Boat slip renewals must resubmit proof of insurance for the current year.

Boat slip renewal payments & documentation must be submitted by March 31st; else the assigned slip will become available.

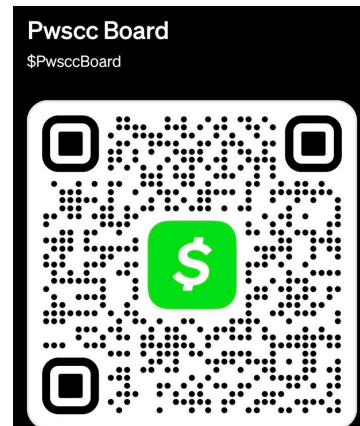
All dock and/or ramp users must read and agree to the PWSCC Marina, Boat Ramp, and Parking Policy. These include

1. Failure to pay will result in termination of boat slip rental. Boat owner will have 7 days to remove their boat from the slip. See attachment for more detail.
2. Overflow parking is for a maximum of 5 consecutive days. Any vehicle/equipment remaining longer is subject to towing.
3. Accepted forms of payment for deposits and rental fees: Cash, Check, Money Order, Venmo, and CashApp.
4. Payments (non-electric) and applications can be submitted via mail or dropped in the mailbox at the clubhouse.
5. We suggest applicants send notification to PWSCC.board@gmail.com when applications and payments are submitted.
